State income tax treatment varies - some states follow the federal designation, others have their own rules, and several states have no income tax. Donors who wish to claim a state deduction should consult their tax professional. Giving through a donor-advised fund or similar charitable giving account may also simplify deductibility, and many donors choose this route. Please check with your State to see if your donation is acceptable.
